Year 2004 Settlement of Land dispute with the unauthorised occupiers' at Bikaner & taking possession of the land . Ad hoc contributions collected from our Kothari brothers for settling the above dispute

Year 2005 Discussion between Kothari brothers of Kolkata & Bikaner about the future of this land; Unanimously a decision was taken to sell the land.

Year 2006 Our search for the buyer ended as a purchaser was found for the land. Settling of price and selling the same was facilitated after keeping 500 yards (2000 sq ft approx) of road facing land by us - In which Nadas & Satji's temples were re-located. Adhoc Contributions taken from community refunded

Year 2007 First piece of Land was bought at Kolkata under Shree Kothari Bhujas Panchayat Trust at Shikharpur at Kolkata near New Town opposite to the land mark Health resort VEDIC VILLAGE in Sept07. It is on State High way on which State Buses ply regularly. Busterminal is 2 minutes Walk.

Year 2008 And process for further acquisition of adjoining land continues

Year 2009 By this time we have acquired total 39 Cottains.5 Chittack approx land. The Land has 126 ft (approx) width on the main road. Boundary work was started on with Bhoomi Pujan on 30th May2009 and was completed and the Main gate was Installed. Kudos to Han Mohan and Shyam Sundar Kothari for taking responsibility single handedly. At Bikaner New Temple is made at 2000 sq ft of land by Kothari Medical Centre (Bikanr) under the guidance of Svt G.D.Kothari

It would have been an impossible task without proactive participation of our President Shri J.M. Kothari, Past President Shri C.R.Kothari & VP Shri S.R. Kothari all Working committee members, active members, trustees and support of our generous Chairman of the trust, Shri D.D. Kothari & warmth of Shri Arunji Kothari and fore most Svt. G.D. Kothari our inspirator who has not only been instrumental for settling Land dispute at Bikaner but whose words of wisdom & generosity has always been our source of light & energy for procurement of new land at Kolkata and beyond.
